2. The eligible candidates shall be called for interview on the date and venue to be specified separately.
3. No TA/DA shall be paid for appearing in the interview.
4. Mere calling for interview shall not entitle the candidate for selection.
5. The interview shall be conducted by the Committee to be constituted by the Government.
6. The selected candidate shall enter into an arrangement with this office that they shall not claim any future engagement on the basis of service rendered or leave the assignment before the completion of contract period. An affidavit duly attested by 1st Class Judicial Magistrate to this effect shall also be produced by the selected candidates.

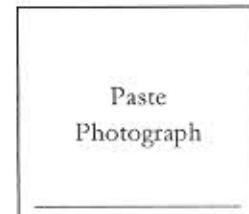
